

Chapter 6

Teaching-Learning Approaches and Assessment Methods

A. Teaching-Learning Approaches

The teaching and learning approaches in the Master of Education Study Program social science is carried out with the principle of student-centered learning (student-centric learning) and utilizes innovative media based on the progress of Information Technology and various learning resources that are available and can be accessed by teachers and students together. Lectures carried out with the Semester Credit System (credits). The number of face-to-face lectures is 16 times per semester, including midterm and end of semester exams. The form of learning and the allocation of time required for face-to-face meetings per 1 (one) credits are carried out as follows.

- Lecture, Response, and Tutorial, consisting of: i) 50 minutes of face-to-face learning process per week per semester; ii) 60 minutes of structured learning assignments per week per semester, and iii) 60 minutes of independent learning assignments per week per semester.
- Seminar courses or other similar forms of learning, consisting of: i) 100 minutes of face-to-face learning processes per week per semester; ii) 70 minutes of independent learning activities.
- 3) Learning in the form of practicum, studio practice, workshop practice, field practice, research, community service and / or similar learning processes 170 minutes per semester, including for response and report preparation.
- 4) Students are required to attend the learning process with a minimum of 75% attendance.
- 5) Students who do not meet 75% attendance are not entitled to take the final semester exams and the student concerned is given an E.
- 6) The absence of a student due to illness or carrying out an assignment, accompanied by a statement or permit that can be accounted for is counted as attendance.
- 7) Lecturers who have not met the number of face-to-face lectures are required to replace lecture hours and / or equivalent activities.

B. Assessment Methods

Learning assessment aims to measure the achievement of learning objectives set by the Yogyakarta State University Postgraduate Program. Learning assessment is carried out with the following criteria.

- 1) The principles of learning assessment are conducted in an educative, authentic, objective, accountable, and transparent manner that is carried out in an integrated manner.
- Learning assessment techniques are carried out by observation, participation, performance, written tests, oral tests, or questionnaires that are tailored to the characteristics of the course.
- The assessment mechanism is carried out through stages which include: designing, implementing, providing feedback, and documenting the results of the assessment.
- 4) The assessment is carried out in accordance with the semester learning plan.
- 5) Reporting on valuations is realized in the form of numbers or letters that have a certain weight.

The assessment of the Masters Program is carried out through activeness in lectures, lecture assignments, midterm examinations, final semester examinations, and final thesis examinations. Next, assess the achievement of student learning goals

1) Assessment of Lecture Results

Assessment of student learning outcomes for each course is determined by student performance which includes: attendance and participation in lectures, completion of assignments, midterm, and final semester exams. The percentage weights for each element are determined by the lecturer supporting the course.

The final assessment of learning is expressed in terms of numbers that are converted into letters. Rating of numbers is realized with a range of values from 0 to 10, or 0 to 100, while the assessment of letters is realized with letters A, A-, B +, B, B-, C +, C, D, and E. Converting the assessment of numeric forms into letters, weights and categories are determined as follows.

2) Evaluation of Progress of Learning Outcomes

Evaluation of learning progress for students is done to identify obstacles in the learning process in order to plan a more planned, structured, and systemic learning process and to find out the level of students' ability to complete their studies. Evaluation of the progress of learning outcomes is carried out as follows:

- a. The first three semesters for the Masters Program, have taken thesis proposal seminar courses, and a cumulative achievement index (GPA) of at least 3.00.
- b. The first six semesters for the Doctoral Program, have taken dissertation proposal examinations, and a cumulative achievement index (GPA) of at least 3.00.
- c. For students who are declared unable to complete their studies, they will resign and be given a certificate of lecture ever for those in need.
- 3) Thesis Examination

The thesis examination is intended to measure the level of mastery and accountability of students of the Master Program on the implementation and report of the results of their thesis research. Thesis examination assessment includes content assessment and presentation assessment with assessment components, including: structure / logic of thought in thesis writing, depth and breadth of scientific theory relevant to the thesis, theoretical arguments in preparing the framework of thought, originality, methods, including: techniques of gathering / validity / data analysis, the use of research findings for the development of science and technology, the clarity of oral presentation and argumentation, and the use of standard language. Before being tested, the thesis text must be reviewed in advance by Yogyakarta State University Postgraduate Program lecturers appointed by the Yogyakarta State University Postgraduate Program Director

The thesis examiners team consists of 4 (four) people consisting of Chief Examiners coming from Postgraduate Program Managers or appointed Study Program lecturers, Secretary Examiners coming from appointed Study Program lecturers, Examiners from Thesis Supervisor and Main Examiners appointed by Vice Director I on Academic Affairs.
